## COMPLYING SUPERANNUATION FUND STATEMENT

ANZ Smart Choice Super offers insurance that meets the minimum requirements set out in the *Superannuation Guarantee (Administration) Act 1992*. Members may only cash preserved benefits in circumstances permitted by the SIS Act.
