1 Introduction

1.1 About ANZ Cashactive Control/Virtual

ANZ Cashactive is an advanced, web-based self-service platform for customers to manage client monies (Cashactive Control) or intra-company cash (Cashactive Virtual).

ANZ Cashactive Control (CAC)

- · Supports the segregation of client monies
- Provides the ability to add, modify and close client accounts without having to contact ANZ
- Incorporates workflows, control and permission levels to effectively manage client funds
- Allows beneficiary details to be recorded against client accounts
- Streamlines account reconciliation by enabling payments to be initiated from client accounts
- Enables automatic or manual allocation of transactions

ANZ Cashactive Virtual (CAV)

- Management of consolidated company-wide cash through a single bank account
- Increased visibility of activities and insight into inter-company relationships
- · Reduced manual intensive operations and associated costs
- Streamlined bank accounts and supporting processes

1.2 About this document

This document is designed to:

- Collate the various file formats for ANZ Cashactive Control and Virtual
- Be a file format specification guide only

This document will be updated with new functionality and information when necessary. Please ensure you regularly check the available version <u>here</u> to ensure you have the most up-to-date copy.

1.3 Scope

This document applies to the following ANZ Cashactive file formats:

- Account Import File Formats this sets out the requirements of client and/or sub-account creation.
- Payment File Formats this sets out the requirements of payment files (including domestic payments, internal transfers and internal receipts)
- Balance and Transaction File Formats this sets out the format of the balance and transaction file that you may receive

2 Cashactive Control – AU Account Import File Format (Web)

2.1 Overview

The Account Import file format (Web) allows a user to import a CSV file containing a batch of Account Holders including one or more beneficiary details and one or more allocation rules into the ANZ Cashactive Control user interface (UI).

The AU Account Import includes file specifications for:

Retail Look Through (RLT)

Retails Look Through (RLT) is an interest rate agreement feature available for ANZ's eligible Intermediary customers – primarily but not limited to those who manage monies on behalf of their clients such as Superannuation Funds, Platform providers and Brokers.

At the time of onboarding onto Cashactive Control, the Natural Accounts are configured to be either Retail Look Through enabled = Yes or No, and the file format requirement varies depending on this Configuration. Refer to "Row Order Restriction and Definition" in Sections 2.5 – 2.16 for the file format requirements for Retail Look Through.

Approval from ANZ is required if you wish to make changes to these configurations, please contact your ANZ Representative.

2.2 CSV File Layout and Character Set

The following character set is allowed in a CSV file:

Fields that are marked 'Alpha' (Alphanumeric) in the 'Type' column are limited to:

Letters: A-Z, a-z

Numbers: 0-9

• The following Characters: spaces () , hyphens (-), full stops (.), forward slashes (/)

Restricted/Invalid characters includes: $[\neg()*^{\$}_{1}]?<>;:,@^{\#}_{1}=[`+']$

• at symbol (@) only valid in email fields

Fields that are marked 'Numeric' in the 'Type' column are limited to:

Numbers: 0-9

2.3 Detail Record

Each Detail Record contains information used to create one Account Holder including one or more beneficiary details and one or more allocation rules (Detail Item).

There may be many Detail Records in one CSV file.



All fields must be separated by a comma (,) and each record will end with CRLF (carriage-return/line feed).

This single file format caters for Account Holders, Beneficiaries and Allocation Rules. Each file record type in the file has a predetermined maximum number of columns. Any data within the file over and above the maximum number of data items for the file record type will be ignored by the system.
