TARGET MARKET DETERMINATION

PURPOSE OF THIS DOCUMENT

ANZ is legally required to prepare this Target Market Determination (TMD). The TMD describes the class of customers the product has been designed for, the conditions under which the product must be distributed and how ANZ will review this document so it remains appropriate.

TARGET MARKET

ANZ has identified the target market for ANZ Business Extra account and the key attributes of the product that meet the needs, objectives and financial situation of customers in the target market as follows:

ANZ Business Extra has been designed for customers who:	Key attributes of ANZ Business Extra that make the product appropriate for the target market:
Are running a business (whether or not for profit);	 Eligibility: ANZ Business Extra is only available for business purposes. Compatibility: Allows customers to integrate account data with eligible accounting software.
Require access to their funds on demand, but who are willing to accept transaction fees if the number of transactions in a month exceeds the set maximum limit of included monthly transactions.	 Transactional ability: Allows customers to access funds and make and receive payments through multiple payment methods on demand. Transaction Fee: Transaction fees apply on Staff Assisted Transactions, Manual Merchant Deposits and Cheque Transactions over a certain included monthly limit.
Want the ability to make and receive payments frequently through one or more of the payment methods offered by ANZ; and	Payment methods: Payments can be made through a range of methods, including digitally.
 Are prepared to pay a fixed monthly account servicing fee but want the option of an Overdraft facility with personalised pricing. 	 Fees: A fixed monthly account servicing fee. Fees may apply if a transaction is initiated from an account containing insufficient funds and for certain transaction types. Overdraft facility: Optional linked Overdraft with personalised pricing.



DISTRIBUTION CONDITIONS

ANZ applies the following conditions and restrictions to the distribution of ANZ Business Extra so that the product is likely to be provided to customers in the target market.

These conditions and restrictions:

- limit the channels through which the product can be provided;
- ensure those who distribute the product are adequately trained and accredited; and
- ensure ANZ only distributes the product in accordance with a consistent application and assessment process.

	Condition	How does this make the distribution appropriate?
Channel	 ANZ Business Extra can only be provided to customers through the following channels: ANZ Commercial; ANZ National Business Centre; Online channels (this may include anz.com, ANZ App and ANZ Internet Banking); ANZ Branches; and ANZ Private. ANZ Business Extra cannot be distributed by third parties. Brokers may refer customers to ANZ, however only authorised ANZ staff may decide to issue the product to a customer. 	By limiting channels, ANZ can ensure that applications for ANZ Business Extra are only received through channels that are subject to appropriate conditions, controls and/or monitoring.
Training & Accreditation	ANZ Business Extra can only be provided to customers by ANZ directly, or through ANZ staff who are accredited and trained.	By applying training and accreditation standards to ANZ parties who distribute the product, ANZ is ensuring: • background checks are conducted on relevant individuals; • those distributing the product hold appropriate qualifications, are authorised to engage in distribution activities and are appropriately trained and accredited to ANZ standards; and • those distributing the product understand the distribution process ANZ requires them to follow, as well as the legislative framework relevant to their activities.
Process	ANZ Business Extra can only be provided to customers by following ANZ's customer application and product selection process, including making relevant enquiries into the customer's product needs.	By applying its application and product selection process, ANZ makes enquiries to determine whether the product is consistent with the likely needs, objectives and financial situation of the customer.

REVIEW OF THE TARGET MARKET DETERMINATION (TMD)

ANZ will review the TMD periodically to ensure it remains appropriate.

Periodic Reviews of the TMD	Timing
 Initial review 	No later than 18 months from the date the TMD is made.
Subsequent ongoing review	No later than 18 months from the date of the previous review.

Review Triggers

In addition, ANZ will review this document earlier if one or more of the following occurs, where they reasonably suggest that the TMD is no longer appropriate:

- There is a material change to the product or its distribution. For example, a change to a key product attribute or a material change to a distribution channel.
- There is a change in law or its application, a change in relevant industry code, an AFCA determination, a court decision, or ASIC or other regulatory guidance or action that materially affects the product. For example, if a change in the law requires ANZ to change or remove a key product attribute or a product intervention order is made by ASIC in respect of the product.
- There is a significant increase beyond expected levels in complaints or disputes, or a significant change in the nature of complaints or disputes relating to the product.
- ANZ has information about the way in which the product is being distributed, operating or being used by customers that reasonably suggests the TMD is no longer appropriate. For example, ANZ will monitor:
 - number of accounts that customers opt to close shortly after the product is issued; and
 - number of accounts that appear inactive for prolonged periods.
- Any other event occurs or information is received (for example, significant dealings in the product that are not consistent with the TMD) that reasonably suggests the TMD is no longer appropriate.

REPORTING

Regulated persons must provide the following information to ANZ:
